**Applicants must meet our low income guidelines (at or below 150% of poverty level). Please check one appropriate box.**

- There are 2 people in my household and total income is at or below \$24,690.
- There are 3 people in my household and total income is at or below \$31,170.
- There are 4 people in my household and total income is at or below \$37,650.
- There are 5 people in my household and total income is at or below \$44,130.
- There are 6 people in my household and total income is at or below \$50,610.
- There are 7 people in my household and total income is at or below \$57,090.
- There are 8 people in my household and total income is at or below \$63,570.

- I will continue to volunteer for at least one year from completing my mock mediation.
