Our Vision:

A South Sound community that has and uses healthy and respectful conflict resolution skills.

Our Impact

In 2019 the DRC helped a total of **6,168** residents of Thurston and south Mason Counties navigate and prevent conflict through mediation, facilitation, training, youth outreach, conflict coaching, and our Conflict Resolution Resource Line - an increase of **35%** in the number of people served from the prior year.

Program Highlights

3,823 people participated in **Trainings and Community Presentations** in 2019 - a **71%** increase.

We launched a new **Small Claims Court Mediation Program in Mason County**, supported by a court rule requiring mediation as a first step.

Group Facilitations increased by **200%** in 2019.


Our multi-year efforts to help schools implement **Restorative Justice Approaches** resulted in one local high school experiencing record low suspensions.
