Reporting to the DRC's Board of Directors, the Executive Director is responsible for ensuring that the organization operates internally and externally in alignment with its strategic direction, mission, vision, and values, as well as leading the organization's staff and volunteers, and setting its culture and team expectations.

The Dispute Resolution Center of Thurston County (DRC) is a 501(c)3 not-for-profit organization, serving residents of Thurston and south Mason Counties, with a mission to empower people to resolve their disputes by providing conflict resolution services and training community members in those skills.

The DRC is a member of Resolution Washington, a network of 21 community mediation centers serving residents across Washington State, Non-Profit Association of Washington, Washington Mediation Association, South Sound Partners for Philanthropy, and the National Association for Community Mediation.

Since our founding in 1991, the DRC has advanced a vision of a South Sound community that has and uses healthy and respectful conflict resolution skills. That's a legacy of 33 years of empowering our neighbors to repair relationships, resolve disagreements, and communicate with respect and civility.

#### **Our Services**

The DRC offers a wide variety of resources for individuals, families, businesses, organizations and communities to help manage and resolve conflict, and to prevent conflict when possible.

Mediation - Our trained and certified mediators serve as impartial facilitators to help people in conflict work toward mutually beneficial agreements.

Conflict Resolution Resource Line - We provide conflict coaching, offer information and referrals, and arrange face-to-face mediations.

Housing Support – We provide voluntary landlord - tenant mediation and renter certification classes to help people maintain housing stability.

Group Facilitation - We help work teams and other groups run orderly and productive meetings, to achieve key goals.

Training - We provide customized training to businesses and organizations to prevent and manage workplace conflict, promote teamwork, and improve customer service.

Youth Empowerment & School Support - We partner with local schools to offer training and support to help the next generation communicate through conflict.

Restorative Justice Facilitated Dialogue - We partner with Thurston County Therapeutic Courts to help individuals affected by crime engage in difficult conversations to heal the harms caused.

## **Our Community**

The DRC's primary service area is comprised of Thurston County and south Mason County - including the cities of Olympia, Lacey, Tumwater, Yelm and Shelton - with a total population of approximately 350,000 people.

Situated on the southern end of Puget Sound, mid-way between Seattle and Portland, the Greater Olympia area includes the Washington State Capitol and numerous state government agencies, as well as a fast-growing private-sector



business sector and a collaborative non-profit community. Our region is also blessed with a vibrant arts and culture scene, and a wealth of outdoor recreational opportunities.

## **Compensation & Benefits**

This is a full-time, exempt position with an annual salary range of \$91,000 to \$112,000, depending on experience. Benefits offered include health insurance, paid holidays, paid personal leave, and agency-match contributions into a 403(b) retirement account up to 3% of pre-tax salary.
